### CBIC Notification 12<sup>th</sup> week

#### **1. Notification No. 13/2023 – Central Excise, Dated 20<sup>th</sup> March 2023.**

There is a reduction in the Special Additional Excise duty on the production of Petroleum Crude to “Rs.3500 per tonne” from Rs.4,400/- per tonne.

#### **2. Notification No. 14/2023 – Central Excise, Dated 20<sup>th</sup> March 2023.**

There is an increase in the Special Additional Excise duty on Diesel to “Rs. 1.00 per litre” from Rs. 0.50 per litre.

#### **3. Instructions – Central Board of Excise & Customs, dated 21<sup>st</sup> March 2023.**

The Board directs that in all pending cases in respect of Department of Posts and Ministry of Railways, where the duty/tax has been demanded only on account of the fact that amount due as tax/duty has not been paid as per the procedure laid down (NSDL portal or ACES Portal) but by book adjustment, the adjudicating authority may focus on the reconciliation of duty/tax paid by book adjustment.

Notices for this purpose, submit the reconciliation statement of duty/tax liability and the payment proof in the appropriate head and account pertaining to the demand to the satisfaction of the adjudicating authority.

The certificate to this effect from O/o CGA may also be provided by the notices.

#### **4. Order No.02/2023 – Service Tax – CBIC, dated 21<sup>st</sup> March 2023.**

Appointment of Commissioner of Central Excise and Service Tax as the Central excise officer to exercise the powers of Chapter V of finance Act 1994, to adjudicate Show Cause Notice in respect of M/s Lawson Tours and Travels (India) Private Limited and made answerable to the other Central Excise Officers.

## **DGFT Notification – 12<sup>th</sup> week**

#### **1. Public Notice No. 61/2015-20 – Customs, Dated 20<sup>th</sup> March 2023.**

1. Procedure for the Registration Certificate for the import of marble and Fresh (green) Areca Nut from Bhutan without Minimum Import Price (MIP) is specified.
2. For the Financial year 2023-24, onwards a total of 17000MTs of Fresh (Green) Areca Nut and 10,000 MTs of Marble may be imported without MIP from Bhutan.
3. For the Financial year 2023-24, the last date for filling online application for RC shall be 10<sup>th</sup> April, 2023.

#### **2. Notification No. 62/2015-20 – Customs, Dated 22<sup>nd</sup> March 2023**

The Notification No. 29/2015-20 dated 28.08.2018 is amended to the extent that the Export of Biofuel from Special Economic Zone (SEZ)/ Export Oriented Zone(EoUs) are allowed for fuel as well as Non- fuel purpose without any restrictions when produced using imported feed stock.
