1. Notification No. 06/2023 – Dated 22nd May, 2023

The export of “Cough Syrup” under ITC (HS) Codes falling under the Heading 3004 shall be permitted subject to the export being tested and production of Certificate of Analysis (CoA) issued by any of the laboratories as mentioned in Para – I above, with effect from 1st June, 2023.
