1. Notification No. 17/2023 – Central Tax, Dated 27th June 2023.

Extension of due date for filing of return in FORM GSTR-3B for the month of May 2023 for the persons registered in the districts of Kutch, Jamnagar, Morbi, Patan and Banaskantha in the state of Gujarat upto 30th June 2023.

The notification shall come into force with effect from 20th day of June, 2023.

1. Notification No. 15/2023 – Customs, Dated 29th June 2023.

The import policy of cigarette lighters under ITC(HS) codes 96131000 and 96132000 is revised from "Free" to "Prohibited". However, import shall be free if the import value is Rs.20/- or above per lighter.
